1. Trey Carrington called meeting to order at 9:03 A.M. and welcomed guest.

- 2. Dianna Moore read the minutes from the previous meeting. Kasey Hibbitts made the motion with Klay Mitchell seconding to approve the minutes. Motion carried 5-0.
- 3. Kirby Gober presented the Hospital bills and report to the court. He stated that the hospital board approved the bills in the amount of \$222,285.01. Patient census have been up, so the supplies bills have been higher. Greg Brockman made the motion with Casey Wells seconding to approve the report and pay the bills. Motion carried 5-0.
- 4. Trey Carrington made the motion with Casey Wells seconding to approve and sign the amendments that were requested by King Creek Wind Farm 1 LLC to the Abatement Agreement between Throckmorton County, TX and King Creek Wind Farm 1 LLC (f/k/a King Creek Wind Farm, LLC) dated August 24, 2020, related to a 140.5 MWac wind farm project constructed on property owned by Ross McKnight which is within the Throckmorton County Reinvestment Zone 2020-02. The improvements have an estimated cost of \$140,000.00. Motion carried 5-0. Agreements are attached.
- 5. Trey Carrington made the motion with Casey Wells seconding to approve and sign the amendments that were requested by King Creek Wind Farm 2 LLC to the Abatement Agreement between Throckmorton County, TX and King Creek Wind Farm 2 LLC (f/k/a King Creek Wind Farm II, LLC) dated August 24, 2020, related to a 203 MWac wind farm project constructed on property owned by Ross McKnight which is within the Throckmorton County Reinvestment Zone 2020-02. The improvements have an estimated cost of \$209,000.00. Motion carried 5-0. Agreements are attached.

- 6. Casey Wells made the motion with Greg Brockman seconding to use ARPA Funds for the Fiberoptic Windstream services. Motion carried 5-0.
- 7. Klay Mitchell made the motion with Casey Wells seconding to make improvements to the County Show Barn using MZ Spray Foam who made a bid of \$31,680.00 to insulate the inside, seal it and paint. Will start closer to the middle of August. Motion carried 5-0.
- 8. Casey Wells made the motion with Kasey Hibbitts seconding to place the County in a County Wide Burn Ban that will expire October 9, 2022. Motion carried 5-0.
- 9. Klay Mitchell made the motion with Kasey Hibbitts seconding to not waive the penalty and interest on taxes for Mr. Justin Johnson. Motion carried 5-0.
- 10. Citizen's Comments: Caleb Hodges stated that they are still taking bids for the Ambulance and that the paper will rerun the ad with the correct information and then will come to Commissioner's Court for approval if any bids are received.
- 11. Elected Officials Report: Brenda Rankin stated that she received an email from Dede Smith regarding the estimated tax value. The email is attached.
- 12. Brenda Rankin presented the bills to the court. Kasey Hibbitts made the motion with Trey Carrington seconding to approve and pay the bills. Motion carried 5-0.

FIRST AMENDMENT TO TAX ABATEMENT AGREEMENT Between THROCKMORTON COUNTY, TEXAS and KING CREEK WIND FARM 1 LLC

This First Amendment to Tax Abatement Agreement (this "Amendment") is entered into by and between Throckmorton County, Texas (the "County") duly acting herein by and through its County Judge, and King Creek Wind Farm 1 LLC, a Delaware limited liability company (formerly known as King Creek Wind Farm LLC, together with its successors and assigns, "Owner") effective as of the 11 day of 12 day of 2022.

Recitals

- A. <u>Tax Abatement Agreement</u>.
